
Safeguarding in Higher Education

What is cuckooing?

Cuckooing might also be referred to as "home takeover", or "home invasion". It involves criminals taking control of another person's home in order to use it for criminal activity.

This criminal activity could involve offences relating to drugs, sexual abuse, and weapons. Criminals might also use the property to store money or stolen goods, or simply as a place to sleep.
