Definitions are hard to come by for physical abuse in adults

Physical abuse including:

- assault
- hitting
- slapping
- pushing
- misuse of medication
- restraint
- inappropriate physical sanctions

Physical abuse is defined as deliberately hurting a child and causing physical harm (Department of Health, 2017;

Humber Project has shown that injuries occur due to accidents that have a high risk of reoccurrence as well as deliberate physical abuse

Not all physical violence results in a discernible injury

Where has the data come from?

Searched the SAR library in September 2023

Initially 339 results

'skim read', discarded non-relevant SAR's


61 cases in total finally used




The community is a dangerous place

By type of residence





Relationship between victim and perpetrator causing physical harm



UK- victim and perpetrator have no obvious relationship or injury is unexplained, DV=domestic violence, E=exploitation, R= resident on resident, ND= nil documented in SAR, PC=Paid carer


The SAR data was clear- you are more likely to be a victim of serious physical abuse if you lived in the community with the source of harm being those closest to you

- Recognise the greater risk
- Consider how you might put in extra resource for protection
- Use community signposting to provide support for the person




Quantitative SAR data- age and sex

SAR Data- physical abuse



England completed S42 2022-23



Humber data follows the NHS Digital Data for S42

Age

- SARs for physical abuse were notable in that the age of the victim showed a completely different profile to S42 referrals by age
- They also differed by age for SARs for other type of abuse
- Serious physical abuse is more common in the younger age group
- Consider the added risk of the younger age group

Harry, (Mellor, D., 2016) was murdered by his x partner who may have been pregnant with his child, and her new boyfriend, the SAR reports-

'A month or so before he died Harry rang his father and told him that Karen and John were trying to kill him'

'Dean made a complaint to staff at the supported housing provider that the perpetrator's behaviour towards him was unbearable and he wanted to move to different accommodation. Arrangements were made to move him the following day, which Dean was happy about. That same evening, the perpetrator went into Dean's room and stabbed Dean to death while he was sleeping in his bed.'

Antecedent (sentinel) Injuries

- Look upon a prior injury as a warning sign

'On 6th October 2013 the Police recorded a racially aggravated common assault where Mr X had repeatedly punched Kamil in the communal area of their accommodation.' Kamil Ahmad (Ohdedar, D., Dalton, M,2018)

Adult A (Lancashire SAB) had a 'small graze on her leg'

Should I be worried about any anatomical location of injury ?





Figure Combination of Anatomical Site of Injuries Sustained by Adults

The potential for cognitive impairment may add to risk

Capacity Assessments in Potential Physical abuse

- The person doing the assessment must understand what the risk of physical abuse may pose to the individual

- 'About 6 years ago I worked with another support worker called..... I recall that she once asked me if I had noticed any bruising on Karen's neck. I had not but the next time I saw her which was within a couple of days I looked and did notice that Karen had a number of prominent bruises on her neck (and) the pattern and distribution looked like finger marks to me. I cannot recall if I asked Karen about the bruises because Simon was always there but I think we did make a report about the marks which should be in their file with Lifeways, it would have been an incident and accident report.' Karen (WSAB,2017)



The association with exploitation

'one person, either opportunistically or premeditatedly, unfairly manipulates another person for profit or personal gain' (Gardner, A., 2024).

Tom's property, (Cheeseman, P., 2017), was visited by many unwanted visitors particularly sex workers,

'Another associate (a known sex worker) had taken Tom's fob which allowed her access through the security system of the address.'

'He said individuals have been staying at his property against his will for approximately a month but these have now been removed following him contacting the police'

Modern Slavery and Human Trafficking and Physical Abuse

'one of the men beat her and that two of them took her in the van to on the day the bailiffs attended the property and that one of them had a knife.' (Drina)

'the abuse that she experienced, including physical abuse, being given drugs to stay awake, being forced to look after the family's animals, and having to care for the children.' (Adult D)

Sexual Exploitation and Sexual Abuse the association with Physical Abuse

- *'that she had experienced further serious sexual abuse, exploitation and physical assaults by multiple perpetrators, both on and off the island.' Miss T.*

'same patients became distressed when he simulated masturbation in front of them and their new colleague' as well as, 'the male care worker getting into bed with this patient'. Beacon Lodge
