Duncan is the founder and Chief Executive of **We Are Survivors**, the largest voluntary sector organisation in the UK providing therapeutic and advocacy support to male (and trans and non-binary) victims/survivors of sexual harms.

Works with the Government, NHS, Crown Prosecution Service and various Police forces across the UK advising on policy including VAWG Strategy, End to End Rape Review, Victim Strategy, the NHS SAAS, the Victims and Prisoners Act 2024; and in Europe, USA, Iceland, New Zealand, and Uganda.

He is a member of Victims Reference Group in the Office of the Victims Commissioner, VAWG Reference Group, and GM Justice and Rehabilitation Executive, and GBV Board.

Duncan's been story consultant for Hollyoaks, Coronation Street, Eastenders and Casualty, and number of theatre productions.

In 2020 Duncan received an OBE from Her Majesty The Queen for services to Male Victims of Rape and Child Abuse; was awarded the UoM Medal of Honor for his work with male victims/survivors of sexual abuse and exploitation; and is now a designated Honorary Senior Research Fellow in the School of Criminology.

DEFINITION: RAPE



A person (A) commits an offence if:

- 1. he intentionally penetrates the vagina, anus or mouth of another person (B) with his penis,
- 2. (B) does not consent to the penetration, and
- 3. (A) does not reasonably believe that (B) consents

However, the introduction of the Sexual Offences Act (2003) made it possible for a female to be charged and convicted of rape as secondary offender.

Richards was previously convicted of sexual assault of 7 year old girl, and in 1988 was convicted of rape of 15 year old girl

- Male rape became a crime in 1995, following an amendment to Sexual Offences Act (1956), via the Criminal Justice Act (1994).
- Andrew Richards became the 1st person to be convicted of Attempted Rape along with Indecent Assault and ABH.
- Richards had a long history of sex crimes
- Judge Richard Lowry QC said the new law gave him greater sentencing powers to combat the growing problem of male rape, stating that Richards was "a danger to the public and children of both sexes".



DEFINITION: CSA



"when a child or young person is pressurised, forced or tricked into taking part in any kind of sexual activity with an adult or young person"

NSPCC (2008)

"Actual or threatened physical intrusion of a sexual nature, whether by force or under unequal or coercive conditions"

United Nations (2017)

"overt or covert sexual behaviour between two individuals when the sex act is developmentally inappropriate for at least one of the participants"

"the engaging of a child in sexual activities that the child does not understand, to which the child cannot give informed consent, or which violate the social taboos of society"

"the use of a minor to meet the sexual or sexual / emotional needs of another person"

DEFINITION: CSE



"What distinguishes the concept of child sexual exploitation from other forms of child sexual abuse is the underlying notion of exchange present in exploitation.

While these two phenomena must be distinguished, it is also important to acknowledge that there is considerable overlap between them, and that, semantically, the distinction will probably never be completely clear.

For example, many cases of child sexual abuse also involve some kind of benefit to the child or exchange—often to win trust or ensure silence (especially non-tangible benefits like small gifts, attention, and affection).

Similarly, the idea of exploitation is arguably applicable to all victims of abuse in the sense of exploiting the vulnerability of a child."

DEFINITION: SSO



A serious sexual offence is a <u>crime with a sexual nature</u>

Offences include:


- Rape
- Any sexual activity that is forced upon a person (either through a physical sexual assault or a psychological sexual assault)
- Creation or possession of certain types of images (static, moving, fictional)
- Trafficking of people or persons (including internally within a country)
 - Sexual Offences Act (2003)
 - Sexual Offences Act (1967)
 - Intimacy with Children Act (1960)
 - Sexual Offences Act (1956)








AN INCONVENIENT TRUTH?





Met chief says millions of men are danger to women and girls in England and Wales

Millions of men in England and Wales pose a danger to women and children, the commissioner of the Metropolitan police has said.

Sir Mark Rowley said the figures were "eye-watering" and an "inconvenient truth"

There are up to 4 million perpetrators of violence against women and children, who are mainly men

Millions of men in the country pose a risk to women and children at some level.



BEHIND THE VAWG DATA







In 2020/21, the Annual CPS VAWG data evidences:

- 1 in 6 Domestic Abuse victims are male
- 1 in 7 Rape victims are male
- 1 in 4 Child Sex Abuse victims are male (boys)

In 2022/23, the Annual CPS VAWG data evidences:

- 17% Domestic Abuse victims are male
- 13% Rape victims are male
- 24% Child Sex Abuse victims are male (boys)

The latest ONS figures (July 2025) from CSEW show

- 8.4% men and 12.8% women aged 16+ victims
- 1:4 (males/females) experienced sexual assault
- 159,985 males over 16 victims in 2024-25




- Research suggests that **1** in **6** males will experience sexual abuse, rape or sexual exploitation
- 1 in 4 victims of child sexual abuse are boys
- **275,000 men over 16** had experienced sexual assault/abuse in 2022 (ONS 2022)
- 20% of males samples in a data dive took over 31 years to disclose childhood sexual abuse
- 5% of boys and young men experience sexual abuse before the age of 16
- 1 in 10 victims of rape are male
- Boys are generally more likely than girls to be abused by people in occupational positions of trust or authority
- Less than 1/3 of male survivors have disclosed



BEING DIFFERENT





- Commissioned by Deputy Mayor of Greater Manchester, Kate Green
- Authored by Professor David Gadd and Duncan Craig OBE
- Plan for Tackling GBV Against Men and Boys is part of the 10 year GM GBV Strategy
- In the year ending June 2024, Greater Manchester Police recorded
 9,904 offences of rape and sexual assault, of which 1,836 male victims
- That's 1 in 5 RASSO crimes are of males.
- The avg time these victims took to report the crime was 4 years
- Less than 4% of reports resulted in a charge

MOTIVATION TO OFFEND

Biological



Sex / Reproduction is a basic human drive and rape / sexual abuse is seen as a mating strategy for relatively unsuccessful males

Psychological



Distorted sexual responses may have been caused by a range of maladaptive early learning / developmental experiences

Sociological



Rape / Sexual Abuse is considered an inevitable product of patriarchal society and paedophilia is seen as culturally historic





OVERCOME INTERNAL INHIBITIONS

Internal Inhibitions may include

- Conscience
- Moral Objection
- Timidity
- Empathy
- Ambivalence
- Social Incompetence
- Physical Disability
- Incest Inhibition Mechanism

Possible ways to overcome them...

- Alcohol & Drug Use
- Fantasy (esp with masturbation)
- Use of Pornography
- Anger/Rage/Paranoia
- Normalisation through 'banter'
- Cognitive Distortions
- Rationalisation
- Social/cultural messages





ADDRESS EXTERNAL INHIBITORS

Environment Selection: considering potential inhibitors



Victim > Environment: consider how/when victim might enter the environment



Victim Selection: *vulnerability / accessibility / desirability*



Victim Contact Strategy: consider potential objectors






ENSURE VICTIMS COMPLIANCE

- Targeting/Grooming of victim is likely to significantly contribute to silence
- Giving gifts
- Targeting vulnerable individuals (strategy supports compliance and/or lack of detection)
- Threats of violence and/or harm e.g. "say anything and I'll kill you"
- Moral force or persuasion
- Offenders may share their cognitive distortions with their victim, e.g. "this is how we show each other love"
- Fear will likely pacify / immobilise the majority of victims and guilt/shame will silence them for many years

BARRIERS TO DISCLOSURE

- Many men do not report as they feel the police would not believe them
- Reluctance to expose themselves to greater scrutiny if they feel their reputations and jobs may be affected by ongoing investigations
- Fear of being judged, e.g. victims sexuality; victims own fault; victim feeling sensations equated to pleasure; that
 the victim "asked for it"
- Confusion of the traumatic events / acts
- "The straightjacket of masculinity" (Hite, S. 1981)
- Rejection
- Avoidance of "Victim" Identity (Etherington, K)
- Shame and Embarrassment
- Guilt, e.g. "I should have been able to stop it"





GUILT & SHAME



Guilt

I DID BAD

Guilt is a feeling about what you did or feel you did

A temporary feeling that you made a decision that didn't live up to your values or the morals of others

LIVED EXPERIENCE

Duncan became friends with John, the local Park Keeper, regularly hanging out playing tennis, bowls and miniature golf.

John bought Duncan gifts, let him smoke, bought him alcohol and let him drink, because they were mates.

But no one saw what was behind the 'friendship'. John's motives were to ensure that Duncan was compliant as he sexually abused him.

Duncan was 17 the last time he saw John, who was mid 50s






LIVED EXPERIENCE

I'm not embarrassed to talk about what I went through. I do still sometimes find bits of it difficult but for the past 18+ years I have been putting myself and my experiences at the front and centre of all my work conversations.


I spent time in New Zealand working with Maroi communities; in America working with male survivors of online exploitation; in Africa with soldiers and men who have experienced sexual violence in war; in Germany with Olympic Athletes, footballers and sportsmen who experienced abuse in childhood. The embarrassment is not mine!






LIVED SILENCE

- Grooming / Manipulation... In some way I think the perpetrator met a need, one maybe two or even more?
- It felt like 'friends with benefits' or rather I never for one second thought this was anymore than friendship
- I 100% knew this was a secret because it was always done in secret, never spoke about, etc
- I didn't want to be called gay
- 5. I just knew that I'd be the one in trouble
- I thought "I liked it"



A BIOLOGY BREAK DOWN



An inability to move,

- debilitation through fear Muscles tighten
- Loss of voice/speech
- Panic sets in
- Sickness/vomiting
- Penis becomes erect
- Experience of Pleasure
- Leaking of semen fluid
- Full ejaculation

- Average measurement between anus (a) and prostate (b) is 3"
- Average size of an erect penis is: 5.6" (source NowPatient 2024)





WHAT TRIGGERS DISCLOSURE?



- A significant life change such as considering becoming a parent, or birth of first child. Their child may be the age
 they were when first abused
- A trigger at work for example a training on child protection
- A death (e.g. Parent, partner, abuser)
- Something in the news e.g. football scandal, Operation Yewtree
- · The support of a loved one it might finally feel safe enough to tell someone
- The feeling that "it's now or never" someone may have hit rock bottom (lost their job, family etc) and may not be
 able to avoid dealing not dealing with their past any longer
- After going through rehab or stopping an addiction, they may be more in touch with their feelings
- Marriage or commitment to a relationship
- TV show, drama, film



HOLLYOAKS

- In 2016, ex Professional Footballers spoke out about the sexual abuse they experienced at Crewe Alexandra, Manchester City, Chelsea.
- Over 20 UK police forces investigating 300 people who had been accused by 849 lads for 2,807 incidents involving 340 different clubs.
- Channel 4 producers recognised how important this reallife story was.
- The team behind Hollyoaks contacted We Are Survivors to ask for help in writing/directing a storyline which sensitively depicted this type of abuse.







IMPACT





- Discussions on social media increased, themes of masculinity
- ISVA queries from 18 25 year olds increase 150%
- Print media stories increased, resulting in referrals for support from adult male survivors of CSE increase 63%
- 4 x High Schools engaged us in developing and delivering an Assembly for boys using Hollyoaks



MANCHESTER REACTS

- I don't think you hear as much about, sort of men getting abused on a night out, so you don't sort of worry about it for yourself
- It's sad to think that people don't think about young men in the same way as they think about young women





NEWSWORTHY





Operation Island

- Reynhard Sinaga
- 38 years old
- Indonesian National
- Studying at University of Manchester

Following a report from (Victim A)...

- 2 year investigation by GMP
- 4 separate trials over 2 years
- 48 men gave evidence
- Greater Manchester Police believe there may be over 200 victims, all male



NEWSWORTHY





In January 2020, Reynhard Sinaga was convicted of:

- 136 counts of rape
- 14 counts of sexual assault
- 8 counts of attempted rape
- 1 count of assault by penetration

In the first two trials, Sinaga was given 88 concurrent life sentences with a minimum 30 year term before being considered for parole.

This was raised to 40 years by the Court of Appeal on 11.12.20.

He will be 77 before he is eligible for Parole.

 Allow time for him to talk in a space he feel safe in

 b. Check out what support he has once he leaves you

Be explicit with boundaries and confidentiality

d. Be empathic and congruent

When words fail him, think about creative techniques

Al and Sexual Harms



Following an investigation led by GMP, Hugh Nelson was charged and convicted of 11 offences, including:

- 3 counts of encouraging the rape of a child under 13
- 1 count of attempting to incite a boy under 16 to engage in a sexual act
- 3 counts each of the distribution and making of indecent images
- 1 count of possessing prohibited images
